RESTORATION ORDER

WHEREAS, the recognition was granted to the institution namely **Delhi Institute of Management and Technology**, Village-Kakra, Post Murad Nagar, Tehsil-Modi Nagar, District-Ghaziabad, State- Uttar Pradesh for offering B.Ed. course of one year duration with annual intake of 100 (One Hundred) only students vide order No. F. No. NRC/NCTE/F-7/UP-2817/2005/61630 dated **10.09.2008** followed by revised recognition order for B.Ed. course of two year duration with an annual intake of 100 students from the academic session 2015-2016 vide order no. NRC/NCTE/F-7/UP-2817/2015/113185-91 dated **06.06.2015**.

2. AND WHEREAS, as per the decision taken by NRC in its 247th meeting held on 23rd to 29th December, 2015 the Committee decided to withdraw the recognition of the institution for B.Ed. course. Accordingly, withdrawal order was issued to the institution on 05.01.2016.

3. AND WHEREAS, the institution filed an appeal under Section 18 of NCTE Act, 1993 against the withdrawal order dated 05.01.2016. The appellate authority vide its order dated 10.10.2023 remanding the case back to NRC with following direction:-

"After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to the NRC, NCTE with the direction to examine and verify the deficiencies pointed out by the V.T. members in the V.T. report and accordingly take appropriate decision in the matter. The Appellant is directed to forward to the NRC the documents submitted in appeal with 15 days from the receipt of order of the Appeal to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The above order is subject to outcome of decision taken by the NRC after following due process as per provisions of the NCTE Act, Rules & regulations. The NRC is directed to expedite the decision in the matter in terms of direction given herein above."

4. AND WHEREAS, in compliance with appeal order, the institution had submitted reply vide letter dated 14.03.2024 received in NRC office 20.03.2024. The Committee considered the reply of the institution dated 14.02.2024 received in NRC on 20.03.2024 and found the same satisfactory.

5. **AND WHEREAS**, the matter was placed before NRC in its 445th Meeting (Volume-2) held on 18th & 19th & 20th August, 2025 and the Committee decided as under:-

"The file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee noted the following: -

- *The recognition was granted to the institution namely **Delhi Institute of Management and Technology**, Village- Kakra, Post- Muradnagar, Tehsil- Modinagar, Distt.- Ghaziabad, State- Uttar Pradesh for B.Ed. course of one year duration with an annual intake of 100 students vide order No. NRC/NCTE/F-7/UP-2817/2008/61630 dated 10.09.2008, followed by revised recognition order for B.Ed. course of two year duration with an annual intake of 100 students from the academic session 2015-2016 vide order No. NRC/NCTE/F-7/UP-2817/2015/113185-91 dated 06.06.2015.*
- *As per the decision of NRC taken in its 247th Meeting, the recognition of the institution for B.Ed. course was withdrawn vide order dated 05.01.2016.*
- *The institution filled an appeal under section 18 of NCTE Act, 1993 against withdrawal order dated 05.01.2016. The Appellate Authority passed an order dated 10.10.2023 remanding the case back to NRC with following direction: -*

After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to the NRC, NCTE with the direction to examine and verify the deficiencies pointed out by the V.T. members in the V.T. report and accordingly take appropriate decision in the matter. The Appellant is directed to forward to the NRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The NRC is directed to expedite the decision in the matter in terms of direction given herein above.

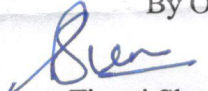
- *In compliance with appeal order, the institution has submitted reply vide letter dated 14.03.2024 received in NRC office 20.03.2024.*

Hence, the Committee decided to restore the recognition granted to the institution namely **Delhi Institute of Management and Technology, Village- Kakra, Post-Muradnagar, Tehsil- Modinagar, Distt. - Ghaziabad, State- Uttar Pradesh** for offering **B.Ed. course of two-year duration with an annual intake of 100 students i.e. two units of 50 students each.**

6. **NOW THEREFORE**, in view of the decision taken by NRC, the recognition granted to the institution namely **Delhi Institute of Management and Technology, Village-Kakra, Post-Muradnagar, Tehsil-Modinagar, Distt. Ghaziabad, State-Uttar Pradesh** for **B.Ed. course** with an annual intake of 100 students i.e. two basic units of 50 students each is hereby restored.

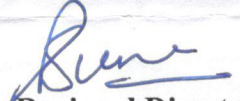
